# TRANSITIONAL PROVISIONS: DEBT AND SPECIALIST SECURITIES LISTINGS REQUIREMENTS

As you are aware, the Financial Sector Conduct Authority published the approval of the amendments to the JSE Debt Listings Requirements, with the effective date as 11 November 2024 (the "Effective Date").

The new JSE Debt and Specialist Securities Listings Requirements (the "DSS Requirements") are available on the JSE's website:

Notwithstanding the Effective Date, the JSE wishes to communicate the following transitional arrangements to allow sufficient time for issuers, debt sponsors, sponsors and designated persons to consume and adopt the DSS Requirements.

## **1.** Transitional Arrangements

Considering the (i) system changes that might be required in order to publish a daily unwind level for structured products and (ii) preparation time involved in the release of results, the following will apply:

2	Financial reporting disclosures for issuers who have ordinary shares primary listed on the Main Board and debt securities listed (paragraph 6.23 read with paragraph 6.5 and General paragraph in section 7)	Applicable to year-ends commencing from 30 November 2024

Reminder letters are an administrative matter and effective 11 November 2024, the JSE will no longer send reminder letters in terms of paragraph 6.18(a) of the current service issue of the JSE Debt Listings Requirements.

#### 4. Service Issue

The JSE is working closely with its publisher LexisNexis and aims to issue the first service issue of the DSS Requirements before the Effective Date. If you are a subscriber to the JSE Listings Requirements, you will receive a notification from LexisNexis how to subscribe for the DSS Requirements.

The JSE will continue to make a PDF version of the DSS Requirements available on its website.
