2. Clearing Fee

The clearing fee earned by JSE Clear is included in the fee charged to derivative members and clients by the JSE for trading derivative instruments. These fees are as per the JSE price list, which can be found at: https://www.jse.co.za/services/other-services/services-documentation/price-lists

The JSE pays over to JSE Clear the clearing fee portion of the fees.

3. Cash Collateral - Interest Consideration

Cash margin collateral posted by derivatives members and clients is invested and managed by JSE Clear. Interest earned on the invested cash is remitted monthly to derivative members and clients, net of the interest consideration retained by JSE Clear.
